Code Enforcement Officer, Mike Olson reported to the Council that he is working on several properties of which two need to be cleaned out so the successful bidder can do the tear-down of the property. The City of Lemmon will also be seeking someone to do mowing for the properties that need to be mowed per code enforcement. Olson noted he has had several complaints against one property, which is a safety hazard, and he is addressing the matter. Olson also spoke about the GE Lemmon house located at 507 3rd Avenue West and the very poor condition of the house. Olson noted that there are several very large cracks in the exterior of the building and it is beginning to crumble. This house is on the historic register, and discussion ensued about that, and what the options are to get it fixed or torn down. Pelkofer asked Mike Olson to contact the owner of the GE Lemmon house to see if it is possible to get inside the house to assess the condition of the interior of the home. This is Olson's first trip to town this year.

Dalzell noted that the BBB Board met and recommends the request of the Boss Cowman Committee of \$6,000.00 be granted for the Boss Cowman Supper during the celebration. Dalzell moved, Pederson second to approve the request. All voting "Aye"; motion carried.

Lemmon Chamber of Commerce requested the street closure of the 200 Block of Main Avenue on July 7-8, 2023, for the activities of the Boss Cowman Celebration. Pederson moved, Becker second to approve the closure. All voting "Aye"; motion carried.

Corcoran moved, Becker second to approve the "open container" for the Boss Cowman Celebration on July 5-9, 2023, in the restricted area as designated and for the specific times designated. All voting "Aye"; motion carried.

Raven Christman spoke about the parade route for the Boss Cowman Parade. The parade will start on 2nd Street West, moving onto Main Avenue, turning right on 8th Street West, and going to 6th

Avenue West, continuing past the Five Counties Nursing Home. Dalzell moved, Becker second to approve the route as presented. All voting "Aye"; motion carried.

Dave Huber presented the Park Board recommendations for summer hire. Dalzell moved, Ericsson second to approve as presented. On a roll call vote, all voting "Aye"; with Corcoran abstaining. Motion passed.

City Attorney, Shane Penfield spoke to the Council about Public Official Liability. Penfield touched on the open meeting laws, executive sessions, and group email/text and noted he is available for any questions at any time.

Public Comment

Tony Wentz talked to the Council that Lemmon is "hurting as a whole and corporations are taking out the Main Street District." Wentz believes that there should be a different tax for the businesses on Main Avenue as opposed to the businesses on the Highway. Wentz noted that business is dying.

Committee Reports

Pederson congratulated Raven Christman on a TV segment that was done by KFYR-TV of Bismarck, ND on the Lemmon Library and all it has to offer. Congratulations Raven.

Huber noted the Sewer Project is moving along with man holes being placed and some of the lining/replacing is in progress. There are some detours around town. Huber also noted the loader is back and in great working order.

Raven Christman reported that she attended a free conference at the Rapid City Public Library and it was a really good conference. Christman also shared that Peggy Douglas will be at the Palace Theatre on Wednesday, May 10, 2023, to do her rendition of Hank Williams at 6:30 p.m. The admission is free.

Abel congratulated the City of Lemmon on the Drinking Water Excellence for the past 18 consecutive years. Dave Huber and Rich Dalzell are certified with DANR for the Drinking Water Programs and were recognized.

Becker moved, Corcoran second to adjourn. Mayor Barnes declared the meeting adjourned at 7:05 p.m.
