## REGULAR MEETING OF THE CITY COUNCIL LEMMON, SOUTH DAKOTA NOVEMBER 7, 2022

Pursuant to due call and notice thereof, the Regular Meeting of the City Council of Lemmon, South Dakota was held on Monday, November 7, 2022, at 6:00 p.m. in the Council Chambers of City Hall.

Mayor Matt Barnes and the following City Council were present: Christine Becker, Wayne Corcoran, Pat Dalzell, Gary Ericsson, Art Pederson, and Tim Pelkofer. Employees in attendance were: Chad Abel, Annette Dalzell, Raven Christman, and City Attorney, Shane Penfield.

Others in attendance were: Colleen Pederson, Jeremy Dunn, Kevin Love, Deputy Sheriff Tim McCartney, LaQuita Shockley, and Mike Schweitzer.

No conflict of interest was declared.

Mayor Matt Barnes called the meeting to order at 6:00 p.m. The Pledge of Allegiance was recited.

Pederson moved, Corcoran second to approve the Agenda. All voting "Aye"; motion carried.

Corcoran moved, Becker second to approve the minutes of the October 3, 2022, Regular Meeting. All voting "Aye"; motion carried.

There was no code enforcement report.

Dalzell moved, Ericsson second to allow the Finance Office to advertise the city leases for cropland, hay land, and grazing land. All voting "Aye"; motion carried.

Ericsson moved, Corcoran second to grant signatory authority to Mayor Barnes to sign the title for the fire truck that was sold to McIntosh Fire Department. All voting "Aye"; motion carried.

The Finance Committee met and recommends the Finance Officer open a new account to satisfy the obligations for the USDA Rural Development Loan and have at least one annual payment in a reserve account for the Sewer Project. The amount in this account will need to be \$68,556.00. Pederson moved, Corcoran second to allow the Finance Officer to open a new account to satisfy this obligation. All voting "Aye"; motion carried.

Mayor Barnes noted the Finance Committee recommends the request to pay the first two payments to Crow River Construction in the amount of \$376,358. 35 from the unassigned fund balance and will pay it back to the unassigned fund upon advancing the loan. This will save the City of Lemmon approximately \$20,000.00 by not advancing the USDA Rural Development Loan for 5-6 months, and if needed at any time, the loan can be advanced and payment made back to the unassigned fund. Dalzell moved, Becker second to make the first two payments in the amount of \$376,358.35 from the unassigned fund balance and pay it back when the loan is advanced. All voting "Aye"; motion carried.

FYI- There will be a Focus Group meeting at the Kokomo on November 29, 2022, at 5:00 p.m. with Dakota Resources being in attendance to talk about ideas for the old high school building. Everyone is encouraged to attend and bring ideas.

6:15 p.m. This being the time and place for the Public Hearing for 2023 Liquor Licenses. Dalzell moved, Corcoran second to approve the 2023 Retail On-Sale Liquor License with Sunday Opening for American Legion Post 66. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Corcoran moved, Becker second to approve the 2023 Retail On-Sale Liquor License with Sunday Opening for Lemmon Recreation. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Dalzell moved, Becker second to approve the 2023 Retail On-Sale Liquor License with Sunday Opening for R-Bar. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Corcoran moved, Becker second to approve the 2023 Package Off-Sale Liquor License no Sunday Opening for Lemmon IGA, Inc. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Dalzell moved, Ericsson second to approve the 2023 Package Off-Sale Liquor License no Sunday Opening for Lemmon Pit Stop. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Dalzell moved, Corcoran second to approve the 2023 Package Off-Sale Liquor License no Sunday Opening for R-Bar. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Corcoran moved, Becker second to approve the 2023 On-Off Sale Wine and Cider License for the Family Dollar. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.

Dalzell moved, Becker second to approve the 2023 On-Off Sale Wine and Cider License for Dollar General. There being no one to speak for or against, the license was approved. All voting "Aye"; motion carried.
