REGULAR MEETING OF THE CITY COUNCIL LEMMON, SOUTH DAKOTA OCTOBER 3, 2022

Pursuant to due call and notice thereof, the Regular Meeting of the City Council of Lemmon, South Dakota was held on Monday, October 3, 2022, at 6:00 p.m. in the Council Chambers of City Hall.

Mayor Matt Barnes and the following City Council were present: Christine Becker, Wayne Corcoran, Pat Dalzell via phone, Gary Ericsson, Art Pederson, and Tim Pelkofer. Employees in attendance were: Chad Abel, Annette Dalzell, Dave Huber, and Raven Christman.

Others in attendance were: Jeff Haase, Mary Haase, Mike Schweitzer, Deputy Sheriff Bill Johnson, Neal Pinnow, Dacia Hilkemeier, and Dave Johnson.

There was no conflict of interest declared.

Mayor Matt Barnes called the meeting to order at 6:00 p.m. The Pledge of Allegiance was recited.

Corcoran moved, Pederson second to approve the Agenda, all voting "Aye;" motion carried.

Ericsson moved, Becker second to approve the minutes of the September 6, 2022, Regular Meeting. All voting "Aye;" motion carried.

6:01 p.m. John Wells, Dorothy Wells, Lorri Bauler, Theresa Wells, Jaren Lonhurst, and Gary Wells entered the meeting.

Mayor Barnes read the proclamation John E. Wells Day and made a presentation to John Wells for his 100th birthday.

6:07 p.m. The Wells family left the meeting.

Mayor Barnes reported that Code Enforcement Officer, Mike Olson submitted his written report. Olson was in town again on September 28-29, 2022, for assessments. Several letters were sent and several have complied.

Pelkofer reported the Property Committee met and discussed the property located at 309 4th Avenue West (Milwaukee Land Co., Second Addition, Block 34, Lot 5). Mike Olson did an inspection of the property and noted it is in dangerous condition and animals are harboring. Olson recommends removing all contents and having the structure demolished. Pelkofer moved, Ericsson second to follow the recommendation of Mike Olson and have the property demolished, and have Olson obtain quotes for the demolition. All voting "Aye;" motion carried.

Dave Huber requested approval to hire a temporary full-time employee to fill in for the next two months while a full-time employee is out for medical reasons. Pederson moved, Ericsson second to approve the hire as requested. All voting "Aye;" motion carried.

Raven Christman informed the Council that Trunk or Treat will be held on Main Avenue in front of the Petrified Wood Park on Monday, October 31, 2022, from 3:00-6:00 p.m.

Mayor Barnes reminded all residents to have all boats, campers, and other vehicles removed from the city streets by November 1, 2022, to help with snow removal.

6:15 p.m. This being the time and place for the Public Hearing for a Temporary Liquor License for Lemmon Legion on October 15-16, 2022, at the Beeler Community Center for a special event. There being no one to speak for or against, Corcoran moved, Becker second to approve the license. All voting "Aye;" motion carried.

This being the time and place for the Public Hearing for a Temporary Liquor License for Lemmon Recreation on November 11-12, 2022, at the Beeler Community Center for a special event. There being no one to speak for or against, Corcoran moved, Becker second to approve the license. All voting "Aye;" motion carried.

This being the time and place for the Public Hearing for a new Liquor License for Shari Smith, R-Bar. There being no one to speak for or against, Corcoran moved, Pederson second to approve the license. All voting "Aye;" motion carried.

Pelkofer spoke again on the meeting of the Property Committee to purchase a 5-wire fence placed on Tract 4 property of the City of Lemmon. The lease is currently held by Chad Abel who put up a new 5-wire fence at the cost of \$5,116.89, which is .95 cents per foot. This property has been fenced by the person holding the lease in the past and then when a new person leases the property it must be torn down and a new fence constructed. Pelkofer noted this is a good deal and it should increase the bid price for future bidding and would eliminate the fence hassle every time a new lease is bid. Pelkofer moved, Ericsson second to pay Chad Abel \$5,116.89 for the fence and the City of Lemmon will own the fence. Dalzell asked if the maintenance would be the responsibility of the new

lease, and it was noted that it would be included in the lease agreement for the maintenance moving forward. All voting "Aye;" motion carried.

Pelkofer noted the third thing the Property Committee recommends is to have a live auction bid process for the upcoming 3-year City Lease Agreements. The process in the past has been submitting sealed bids and then those who submitted a sealed bid could raise the bid at the council meeting. The Property Committee recommends for this 3-year lease period that a live auction be held on all four tracts that will be up for bid, with a minimum of \$10.00 per acre on all properties. Pelkofer moved, Becker second to follow the recommendation of the Property Committee with a live auction and a minimum of \$10.00 per acre on all properties, with the city having the right to refuse any and all bids. All voting "Aye;" motion carried.

Corcoran moved, Becker second to allow the Finance Office to advertise for a Public Hearing of 2023 Liquor Licenses at 6:15 p.m. on Monday, November 7, 2022. All voting "Aye;" motion carried.

Corcoran moved to go into Executive Session per SDCL 1-25-2 (1), to discuss the qualifications, competence, performance, character or fitness of any public officer or employee or prospective public officer or employee. Pelkofer second the motion at 6:25 p.m. All voting "Aye;" motion carried.

6:33 p.m. Mayor Barnes declared the meeting out of Executive Session.

Anthony Bonacci entered the meeting at this time.

Jeff Haase addressed the Council as a citizen of the City of Lemmon, not a Planning & Zoning Board Member. Haase spoke to the Council about a portion of an article in the Dakota Herald October 3, 2022, issue, asking for a correction to the article by the Dakota Herald.

Anthony Bonacci asked to have the minutes of the September 6, 2022, meeting corrected to clarify that he spoke about notification and trespassing on his property not just about his grass.

Pederson moved, Corcoran second to approve claims as presented. Pederson noted a kudos to Dave Huber for hiring Jensen Sand & Gravel to do the street chipping this year and the good job they did. All voting "Aye;" motion carried.
